

## CREDIT REPAIR SERVICE AGREEMENT

It is agreed and understood by both parties that this agreement is made exclusively and solely under the laws of the State of Florida.

- I. This agreement is expressly for Credit Repair services from Servicer to Client.
- II. All information, statements, documents, written, verbal, published, orally made, etc.,, are the sole responsibility of the Client.
- III. Servicer is not a law firm and cannot and will not provide to Client any legal advice or recommendations.
- IV. The Client understands and acknowledges that any Credit Repair attempted and any procedure performed is with the Clients full and complete consent, agreement and understanding and the Client indemnifies the Servicer of any liability that may arise from the credit repair procedure.
- V. Client is responsible for producing all required documentation requested by Servicer, Client is responsible for all claims, allegations, and statements in conjunction with their claim of identity theft.
- VI. Servicer will assist Client with removal of wrongful negative items reported on Client's credit report which the Client claims resulted from identity theft.
- VII. Client must comply with all requests for production of documentation in a timely manner so that Servicer may complete its contractual obligations to Client.
- VIII. Client indemnifies and holds harmless Servicer, its officers, employees, agents, representative, and contractors for any financial or legal injury as a result of Servicer's assistance.
- IX. Client expressly states that all statements made orally or written are those of the Client and do not reflect any ideas, suggestions, motives, encouragement, or recommendations of Servicer.
- X. In the event of a material breach or disagreement by either party it is hereby agreed that any matter of disagreement or breach shall come before arbitration in the City of Miami, located in Miami-Dade County, Florida.
- XI. Client expressly and irrevocably agrees to officially waive his/her/their rights to litigation or civil action against Servicer, its officers, employees, agents, representative, and contractors for any breach of contract, financial injury, legal liability or any action brought for compensatory damages or action brought in equity.
- XII. Client agrees that the arbiter must approved by Servicer and Client agrees that all costs of the arbitration shall be cast exclusively on the party bringing the arbitration.
- XIII. If any part, subpart, section, or subsection of this agreement is found to be unenforceable the remainder of this agreement shall remain in full force.
- XIV. Servicer provides a guarantee of results under the following circumstances, (1) All documentation requested by Servicer is produced to Servicer by Client within a reasonable timeframe to Servicer for credit repair processing. (2) Negative Items that are not removed from the first submission must be re-submitted at least two additional times. (3)If after that any negative items are remaining then they will be divided from the total
